

BEAT THE APRIL 2021 EMV DEADLINE!

In April 2021, all gas stations in the United States will be required to accept outdoor EMV transactions at their gas pumps or else the station owners themselves will be responsible for the financial liability of fraudulent chargebacks and any other fraud associated with non-EMV transactions.
